Features new to this edition include: an update on the state of nursing diagnosis; interventions are grouped according to specific populations - child, older adult, maternal and community; all new nursing diagnoses are included; and a simplified format for nursing diagnoses, which includes generic and specific nursing diagnoses with separate designs for each.
