Following this decision, the New Jersey Legislature enacted a civil unions bill, providing same-sex couples all of the rights, benefits, and obligations of married couples under state law.

Although the civil unions bill provides important new rights, including parenting rights, property rights, tax benefits, and support obligations, it does not provide rights and benefits under federal law, and the rights available under New Jersey law may not be recognized in other states. This thoroughly updated edition of the 2004 guide provides advice to couples in regard to these critical areas of law.
